



LOOKING TOWARDS THE 65th ANNUAL MEETING IN TAIWAN

Dear colleagues,

IAJ has turned 70! Since 1953 our organisation has been successfully campaigning to help secure judicial independence in all countries of the world.

So, what better place than the beautiful city of Taipei, Taiwan, to discuss a rich number of topics on the IAJ agenda and to celebrate our anniversary, with our 65th IAJ annual meeting, surrounded by the warm hospitality and the perfect organisational skills of our Taiwanese brethren!

Those of you who have more or less my age may remember that Taiwan hosted our annual meeting in 1999 (when the original version of our Universal Charter was approved). I have incredibly good recollections of that event: therefore, I am really eager to visit again that wonderful place. This time, as you know, the meeting will take place on 16 th – 21st September 2023. Even from now I want to thank all of the member associations which will be participating (often coming from very faraway countries), but of course, very warm thanks go to the Taiwanese association, with which this Secretariat-General has been constantly working online during the last two years.

Many important subjects will be debated. Apart from the Constitutional Law Forum, to be held on 18th September, co-organised with the Taiwan Constitutional Court (on this peculiar event see Annex I to this newsletter), the four Regional Groups will meet on Sunday, 17th September, followed by the Central Council (on 18th, 19th and 21st) and the Study Commissions (on 19th). The Presidency Committee will meet twice (on 9th, by video conference, and on 17th in presence in Taiwan), as will the Council of Honorary Presidents (on 16th and 17th).

The Central Council will be called to discuss proposals for amendments of our Constitution and Regulations, studied by an *ad hoc* working group, presided over by IAJ President José Igreja Matos. Elections for the IAJ officials will be held, as happens regularly every two years according to our Constitution. For this reason, we ask to all associations which cannot travel to Taiwan to be so kind to give a proxy, in accordance to our statutory rules (a letter on this topic has been sent to you all on July 15).

The Taipei meeting will also, as usual, witness the participation of a number of international guests and observers,

together with observers from prospective new IAJ members, such as Burkina Faso and Burundi.

As to the Study Commissions, these will discuss the following items:

- 1st Study Commission: "The effects of remote work on the judicial workplace and the administration of justice";
 2nd Study Commission: "How data protection rules are impacting on the way judges work in civil litigation";
- 3rd Study Commission: "Mutual cooperation in the investigation of criminal cases and in the presentation of
 - 4th Study Commission: "The judicial workplace and the intersection with judicial independence".

A special booklet will be produced (thanks to the help of our Taiwanese colleagues) to celebrate the event and to underline cornerstones and landmarks of our activities during all these years.

We will be presenting as well interviews with IAJ officials, in order to show the effectiveness of our actions since 1953. Live recollections and pictures will help us to remind us of our past (distant and recent) and also to make new generations of colleagues proudly aware of the role always played by our organisation around the world.

As it happened also last year in Tel-Aviv, there will be as well a moment to mark our gratitude to some champions of judicial independence in the various parts of the world. We are planning to continue with our tradition of awarding the "Judicial Independence Prize" to individuals who have contributed (often paying very high personal prices) to keep the flag of judicial independence flying on and on.

In attendance are the IAJ President Mr. José Igreja Matos, the First Vice President and EAJ President Mr. Duro Sessa, as well as the following Vice Presidents: Mr. Walter Barone (Brazil, President of the IBA Group), Ms. Allyson Duncan (USA, President of the ANAO Group), Ms. Marcelle Kouassi (Ivory Coast, President of the African Group), Mr. Michael Sjoberg (Danemark) and Ms. Sabine Matejka (Austria). MEETING OF THE IBERO-AMERICAN GROUP - SAN JOSÉ (April 2023)



On 12th April 2023, in San José (Costa Rica) the mid-year meeting of the Ibero American Group of the IAJ started. In attendance were 15 member associations from Latin American countries. The meeting took place under the presidency of Mr. Walter Barone (Brazil), with the attendance of the IAJ President, Mr. José Igreja Matos, of the IAJ Secretary-General, Mr. Giacomo Oberto and of the Deputy Secretary-General Mr. Galileo D'Agostino.

The meeting dealt with current problems of the judiciary in Latin America; President Barone illustrated to the delegates the worrying situation of the judiciary in Guatemala, as there is a systematic attack against judges, prosecutors and former officials of the CICIG (International Commission against Impunity in Guatemala) who heard cases of major corruption and human rights violations that occurred during the internal armed conflict.

Many colleagues have had to leave the country and have settled abroad, sometimes as refugees. The precarious situation of these colleagues deserves the solidarity of our group, says the President, who proposes the creation of a Solidarity Fund.

Meeting with the Chief Justice of Nigeria

On 17th February 2023, the IAJ President Mr. José Igreja Matos and the Secretary-General Mr. Giacomo Oberto had a "Zoom" online meeting with the Chief Justice of Nigeria, the Hon. Olukayode Ariwoola. In attendance was also Justice Ngozika Okaisabor (Nigeria). Topics discussed during the meeting were: a) How to set up an Association of Judges and Justices (or representative Group) of Nigeria, which could apply for membership in the IAJ; b) How a newly created Judicial Association could apply for IAJ membership.

The IAJ President and Secretary-General explained the contents of IAJ booklet on the subject of encouraging the creation of Judicial Associations and declared themselves available for providing Nigerian Judiciary with all necessary information on how to create an Association and how to apply for IAJ membership. The Chief Justice of Nigeria declared himself very interested in the intiative and assured his Office would continue keep contacts with the IAJ in order to set the process in motion. IAJ is also very much thankful to Justice Ngozika Okaisabor, a very good friend of us, who facilitated this event and will assist the Nigerian Judiciary in the setting up of an Association.

Proposition to name January 11th "International Day of Judicial Independence - 1000 Robes March"

On 27th March 2023, a letter was addressed to the attention of the Secretary General of UN, Mr. Guterres and in copy to the UN Special Rapporteur on the independence of judges and lawyers, Prof. Margaret Satterthwaite.

The aim of the letter was to propose to name January 11th "International Day of Judicial Independence – 1000 Robes March".

It was signed by the President of the IAJ, Mr. Igreja Matos; the Secretary-General of the IAJ, Mr. Oberto; the President of the EAJ, Mr. Sessa; the President of the IBA, Mr. Barone; the President of the ANAO, Ms. Duncan and the President of the AFR, Ms. Kouassi.

Meeting of the CEPEJ Network of Pilot Courts in Lublin (Poland)

On 30th March 2023, the CEPEJ Network of Pilot Courts of the Council of Europe met in Lublin (Poland) to discuss issues pertaining to judicial efficiency and judicial time management. On 29 and 31 March the CEPEJ-SATURN WG of the Council of Europe met in the same venue, under the presidency of IAJ Secretary-General, Mr. Giacomo Oberto.

The meeting's discussions focused on measures to prevent and reduce the excessive workload as well as to fight backlogs in the courts. The members of the working group also discussed the preliminary analysis of the case weighting systems for prosecutors based on the feedback from the prosecution services in Europe as well as timeframes of different stages of the civil proceedings based on the data submitted by the CEPEJ pilot court Network. The Revised Time



Management Checklist, that will serve for the collection and analysis of information on the relevant aspects of the duration of judicial proceedings and its Explanatory Note have also be examined together with possible follow up to ensure their implementation in practice. The on-line training module on SATURN tools (via the HELP platform) was also discussed, as well as the possible collection of good practices on judicial time management.

IAJ and EAJ (which enjoy the status of observer at the CEPEJ) were represented by Secretary-General Mr. Giacomo Oberto, who submitted as well a presentation in his quality as President of the CEPEJ-SATURN Working Group for Judicial Time Management on the following subject: "Possible update of the Recommendation No. R(86)12 of the Committee of Ministers to member States concerning measures to prevent and reduce the excessive workload in the courts".



The Constitutional Law Forum 2023



The Judges Association of ROC (Taiwan) is hosting the 65th annual meeting of the International Association of Judges (IAJ), and the celebration of the 70th Anniversary of the IAJ in Taiwan this year (2023). Taiwan Constitutional Court (TCC) will be partnering with the Judges Association of ROC (Taiwan) in implementing the Constitutional Law Forum 2023, as one of the sessions of the annual IAJ meeting, on September 18, 2023, at Grand Hyatt Taipei under the theme of *Judicial Independence and Constitutionalism*.

With our theme, the TCC and the Judges Association of ROC (Taiwan) intend to look back on the *Universal Charter of the Judge* (originally adopted by the IAJ Central Council in Taiwan on November 17, 1999 and updated in Santiago de Chile on November 14, 2017) and the issues on Judicial Independence that the IAJ 1st Study Commission has discussed over the years; and reexamine, from the perspective of Constitutionalism, the themes referred to in the *Charter* (2017), which still resonates as important axioms amid the challenges towards Judicial Independence around the world.

The TCC and the Judges Association of ROC (Taiwan) view this forum as an opportunity to facilitate dialogues between participants on the themes of the Charter, to promote exchanges on the theories and practices of Judicial Independence between different countries, and to actively fulfil the ideals of Constitutionalism in the future.



Topics

Judicial Independence from Other State Powers

This topic will focus on the ways of countering pressure from the political departments (i.e. executive branch and legislative branch) towards the judiciary from the perspective of Judicial Independence and Constitutionalism.

- Appointment, confirmation, court-packing (especially on Constitutional Court or Supreme Court judges);
- Compulsory retirement of judges;
- Reduction of remuneration of judges with the intention of political duress;
- Parliamentary actions interfering the process and outcome of cases: resource and budget reduction, congressional investigation powers, interpellation, inquiry toward pending cases, bills against court rulings..., etc.;
 - Misuse or abuse of impeachment of judges;
 - Lustration policy in the judiciary.

Judicial Independence from Judicial Administration

This topic will focus on methods of judicial supervision and legal responsibility of judges from the perspective of Judicial Administration, Judicial Independence, and Constitutionalism.

- Promotions, relocation, transfer, and supervision of judges;
- Limits on the assessment of judges performing official duties;
- Judicial council as a safeguard and the self-governance of the judiciary;
- Civil and criminal responsibility of judges when performing duties and the criterion of judicial immunity.

Judicial Independence from Social Pressure

This topic will focus on contemporary issues regarding Judicial Independence in the midst of the rise of social media from the perspective of societal intervention.

- Protection of professional judges, citizen judges, and their families against disinformation, hate speech, and physical/verbal abuses or attacks;
 - Undue criticism against judgments compromising judicial credibility;
 - Contempt of court and other protective mechanisms for the judiciary.

Judicial Independence and Freedom of Expression

This topic will focus on the protection and limitation of the Judges freedom of speech to meet the requirements of Judicial Independence.

- Judges' public speeches defending their decision-making;
- Judges' comments on finished/pending cases of their colleagues;
- Judges' comments toward legal policies/the legislature;
- Judges' participation in the policy-making process, and in activities regarding political/social issues;
- Judges' extrajudicial speech in the newspapers and social media.
